#### **Conditions**

- 1. Use tamper-proof electronic seals only.
- 2. Open top container is not permitted.
- 3. Transport documents of self sealed container shall be the same as prescribed under the GST Laws.
- 4. Exporter shall furnish intimation to the jurisdictional Superintendent of Customs each time self sealing is carried out at approved premises.
- 5. Export policy conditions prescribed by the DGFT/APEDA/MPEDA/AQCS/ PQIS/WCCB/ FSSAI/Customs etc. from time to time shall be strictly adhered to.
